**All training, warm ups and cool downs will take place in the competition pool according to attached detailed championships program.**

Training facilities will be available for the participating athletes from 02 November until the end of competition.

All swimmers and coaches are requested to follow the warm-up procedure in order to ensure a safe and high quality warm up for all participants.

### 3. ENTRY PACKAGE

#### 3.1 BASIC ENTRY FEE

The registration fee (the Basic Entry Fee) per each person (athletes & team officials) is 100 €. This cost includes:

- Daily transport shuttle (hotel-venue)
- Competition operation costs

Fees must be paid to the competition office upon arrival at the competition.

#### 3.2 CANCELLATIONS/REFUNDS POLICY

<b>Cancellations until the Final Entry Deadline (10 October 2022)</b>	Teams are not liable to pay the basic entry fee for any canceled participants
<b>Cancellations between 11 October and 24 October 2022</b>	Teams are liable to pay 50% of the basic entry fee and 50% of accommodation costs for any of canceled participant (whole team costs in case of canceling participation of the team)
<b>Cancellations from 25 October 2022</b>	Teams are liable to pay 100% of the basic entry fee and 100% of accommodation costs for any of canceled participant (whole team costs in case of canceling participation of the team)

The outstanding fees due to cancellation must be paid to the LOC upon arrival at the competition. In case of canceling a participation of the whole team after 11 October 2022 (and therefore when there would be no possibility for the team to pay at the LOC office), the LOC will issue an invoice for the relevant to the team for payment via a bank transfer.

## 4. ACCOMMODATION/ MEALS

Please be informed, that the LOC is responsible for the whole reservation in Radisson Blu Hotel, a 4 stars hotel with adaptation for people with disabilities. **Please note, that this hotel is the only official hotel for the competition and no other hotels are permitted to be used by competition participants.**

The accommodation fee includes full board alimentation:

- Double room: **100 €** per person per day
- Single room: **130 €** per person per day

**All accommodation fees must be paid directly to the LOC upon an arrival at the competition office, not to the hotel.** The hotel will be in charge only to collect any necessary extra costs incurred during your stay (i.e. laundry, telephone, mini bar, etc.)

### 4.1 EARLIER ARRIVALS

In a normal conditions Radisson Blu Hotel has check-in for guests starting at 2 p.m.

#### 4.2 WHEELCHAIR USERS

To improve arranging accommodation, we kindly ask national representations to fill with care the Final Entry Form with information about wheelchair users. This is a necessary information for booking suitable rooms in the Hotel. Please note that the number of adapted rooms is limited.

#### 4.3 PARKING

This information concerns guests arriving with their own transport. Please be informed, that the LOC will not refund payments for parking at the hotel area. Charges should be paid at the Radisson Blu Hotel reception.

## 5.2 TRANSPORT FROM AIRPORTS:

Please find below suggested airports to travel to the competition place:

### **Goleniów Airport – Poland**

The nearest International Airport is Szczecin Airport (well known as Goleniów Airport - which is located 50 kilometers away from the City Centre of Szczecin).

### **Berlin Brandenburg Airport – Germany**

Another choice is to take flight connection to Berlin Airport (Germany) - which is located 180 km away from Szczecin.

Transfers for the teams arriving to Berlin or other airports can be provided with additional cost as follows:

## 6. COMPETITION DETAILS

### 6.1 TRAINING

A full training schedule for all arriving competitors will be prepared after the LOC receives all entries and will be distributed to all participating teams one week before the competition.

### 6.2 DOPING CONTROL

According to *The World Anti-Doping Code* doping control can be conducted during the competition. Polish Commission Against Doping in Sport will be overseeing the process and will be responsible for the sample collection.

### 6.3 AWARDS

Individual events will be conducted as “point system multiple class events” (the final ranking according to the 2022 World Para Swimming Point Scores). Medals will be awarded only to athletes with World Para Swimming license and international classification.

Relay events will be conducted as “single class events” (the final ranking according to time). Medals will be awarded teams all teams (including both nationally and internationally classified athletes).

Medals in all the events will be awarded following the “minus one rule”.

### 6.4 WORLD PARA SWIMMING LICENSE

Only athletes with World Para Swimming license will be considered for World Para Swimming ranking and record lists.
